

## Information on the processing of personal data

The company Spinbotics s.r.o. declares that, when processing personal data, it will comply with applicable legal regulations on the protection of personal data, including Regulation (EU) 2016/679 on the protection of natural persons in the processing of personal data and on the free movement of such data, which repeals Directive 95/46/EC (General Regulation on data protection) (hereinafter referred to as "GDPR") and Act no. 18/2018 Coll. On the protection of personal data and on the amendment of certain laws. Information on the processing of personal data before granting consent:

1. The Controller of personal data is the company Spinbotics s.r.o, with its registered office at Havanská 2563/5 040 13 Košice - mestská časť Sídliisko Ťahanovce, ID number: 53025580, a company registered in the Commercial Register of the Municipal Court of Košice, oddiel: Sro, vložka č. 48696/V (hereinafter also "Controller" or "Spinbotics").
2. Processed personal data are all data that are able to directly or indirectly identify a natural person (hereinafter referred to as "the data subject").
3. The Controller shall cease to process personal data if the purpose of the processing ceases to exist, at the latest within a period of 2 years or if you withdraw your consent; whichever is earlier.
4. As the data subject, I acknowledge that providing my consent for the purpose of receiving the promotional material called "Newsletter" is voluntary.
5. The withdrawal of consent does not affect the legality of the processing of personal data based on consent before its withdrawal.
6. The purpose of processing your personal data in this filing system is the marketing and promotional activities of the Controller, which includes in particular, but not exclusively, the sending of up-to-date information and news about the Controller's activities.
7. The Controller may internally evaluate your personal data through authorised persons, make extracts, copies, print your personal data in paper form and perform other processing operations in order to achieve the purpose of processing.
8. The processing of personal data in this information system takes place on the basis of Article 6, paragraph 1 letter a) GDPR, and therefore on the basis of the freely granted consent of the person concerned.
9. Personal data is not transferred to third countries.
10. As the data subject, you have the right to request from Spinbotics access to your personal data, their correction, deletion or restriction of the processing of personal data, the accuracy of the data and to object to the processing if the conditions under applicable law are met. 11. As the data subject, you have the right to object to the processing of your personal data. Suggestions can be sent to an email address: [spinbot@spinbotics.com](mailto:spinbot@spinbotics.com).

Furthermore, you have the right to submit a proposal to the competent supervisory authority to initiate proceedings on the protection of personal data in the event that, according to this instruction, your rights have been violated during the processing of personal data i.e. Office for Protection personal data (hereinafter referred to as the "Office") with headquarters located in Hraničná 4826/12, 820 07 Bratislava - Ružinov, Slovak republic.

**READ CAREFULLY:** Consent to the processing of personal data can be revoked at any time by sending a brief information on the revocation of consent to the email: [spinbot@spinbotics.com](mailto:spinbot@spinbotics.com). Withdrawal of consent does not affect the lawfulness of processing based on consent due to its withdrawal. The consequence of withdrawing consent is the exclusion of personal data from use, but not the absolute deletion of personal data that were processed before its withdrawal.
